WHEREAS, parks and recreation encourage physical activities by providing space for popular sports, hiking trails, swimming pools, and many other activities designed to promote active lifestyles; and

WHEREAS, park and recreation programming and education activities, such as out-of-school time programming, youth sports, and environmental education; and

WHEREAS, parks are adaptable infrastructure that make Kenosha County resilient in the face of natural disasters; and

WHEREAS, Kenosha County's parks ensure the ecological beauty of our community and provide a place for children and adults to connect with nature and recreate outdoors; and

WHEREAS, Kenosha County recognizes the benefits derived from parks and recreation resources; and

WHEREAS, the U.S. House of Representatives has designated July as "Parks and Recreation Month;"

NOW THEREFORE, BE IT RESOLVED, that the Kenosha County Board of Supervisors does recognize July 2023 as "Parks and Recreation Month" in Kenosha County; and
