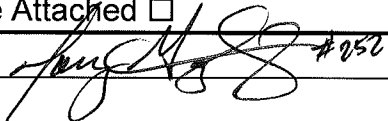

Note: This resolution requires NO additional funds from the general fund.




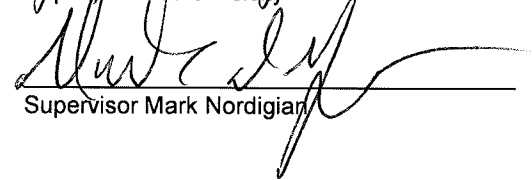
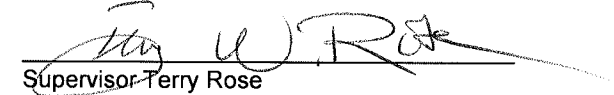
