WHEREAS, the Kenosha County Courthouse is an architectural gem and has been undergoing various restoration and renovation improvements for several years, and

WHEREAS, Kenosha County has been awarded a \$10,000 grant from the Cynthia Woods Mitchell Fund to support the preservation initiatives of historic murals within the Courthouse, and

WHEREAS, in order to receive this grant, Kenosha County must contribute matching funds of \$10,000 which will be used to pay for this project, and

WHEREAS, these matching funds are included in the current 2022 Capital Project Budget and no additional bonded or budgeted funds are needed to complete this project

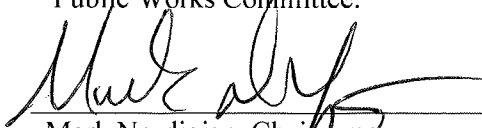

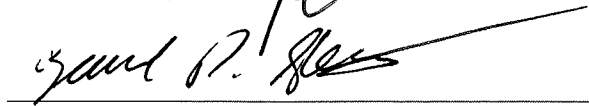
