




I have been interested in mental health services since I was a teenager and lost an acquaintance to suicide. I continued pursuing my interest through my college studies and worked in the mental health field for almost 30 years. Throughout my career I worked with young children to the elderly in a variety of situations. I worked in a juvenile prison, agencies that provided services for abused children and their parent(s) for reunification or termination of parental rights, a nursing home, and in a hospice with the grieving families. I was in private practice for 23 years and held court contracts to work with juveniles in diversionary programs and individual and family counseling. I had a variety of clientele in my private practice.

I feel that I have insight and an understanding of mental health and rehabilitation services that are needed and the delivery system to get them to people.

I feel that I have an awareness of some of the problems we have in Kenosha County and the services that are needed. The high level of suicides that occur, the drug overdoses that continue to climb and the psychiatric issues that seem to be more serious and impact the community in so many ways really concern me. I would like to contribute to the discussion and visioning of solutions to the issues in the community I live in. I hope to be able to be a part of the board.
