## NARRATIVE

Summary of Events: On 7/18/2023 at approximately 1539 hours, I, Deputy Matson #345, was assigned to conduct a cabaret license inspection of BB's Pub, 6215 Green Bay Road. I was informed that the business had applied for this license and that a review of the tavern was required. The owner, Christine Cantrell, provided me with a tour of the premises, and I was shown where entertainment was planned. No violations of any county ordinance or state law were observed during the inspection, and based on my observations, a license should be issued to the tavern.

Narrative: On 7/18/2023 at approximately 1539 hours, I, Deputy Matson #345, was assigned to conduct a cabaret license inspection of BB's Pub, 6215 Green Bay Road. I was informed that the business had applied for this license and that a tavern inspection was required.

Upon arriving at BB's Pub, I observed the tavern on the east side of STH 31 (Green Bay Road), where it intersects with 63<sup>rd</sup> Street. The tavern had a large parking lot that extended from the west side of the building to the south side and then east on 63<sup>rd</sup> Street. Upon entering the tavern through the east side door, I made contact with Christine Cantrell, identified verbally. There were approximately six patrons in the bar. I provided Christine with a copy of Kenosha County Ordinance 8.02.

Christine provided me with the framed and properly displayed licenses for the tavern. I photographed these with my body camera, and those photos are saved under this case number. Some of the licenses in this frame expired in 2023, but I was provided with newly received copies of the licenses to be added. The licenses that were expired were not issued to any on-duty bartender.

I observed the tavern's valid Class "B" fermented malt beverage license and Class "B" intoxicating liquor license, issued through the Town of Somers. This is valid from July 1<sup>st</sup>, 2023, through June 30<sup>th</sup>, 2024. The agent listed on this license is Christine Cantrell, who is the same as the applicant for the cabaret license. Christine is listed as the agent of Rogers Investments, LLC.

An amusement device license, also issued by the Town of Somers, was present, allowing for using five amusement devices. These devices are five video gaming machines positioned on the business's west wall, directly south of the main entrance.

Christine and Jim reported that the tavern had previously possessed a cabaret license when Betty Brown owned it. Betty recently passed away, and David Brown inherited the business. David recently sold the company to Christine, who attempted to restart entertainment in the establishment.

Christine said she plans to host a karaoke night inside the tavern, with the speakers being set up near the north end of the bar and using a previously existing television to monitor the song lyrics. Jim showed me the exterior yard, where a volleyball net was set up along with a paved patio. Jim said previously the bar would have a small stage set up on the western portion of the patio area. Jim said he hopes to place the stage on the east side of the outside area, facing the stage to the west, to avoid noise complaints from the surrounding neighborhood. This outdoor area had a sufficient amount of space for a large gathering.

Christine told me she had already had the building inspected by Town of Somers building inspector. I explained to Christine that KSD needed a copy of this inspection report before issuing a cabaret license.

I observed no minors in the tavern at the time of my inspection. The tavern also appeared to adhere to Kenosha County Ordinance 8.02 requirements. Based on my observations, I would recommend approval of the cabaret license for BB's Pub.

A diagram drawing of BB's Pub is attached to this report. I made modifications to the existing diagram that had been attached to a previous inspection, KSD Case 2022-332710. Reference it for more information on the layout of the tavern. Also attached is the application for the cabaret license and a copy of the class "B" liquor license. My body camera was activated and recorded for this incident.

This concludes my involvement in this case.

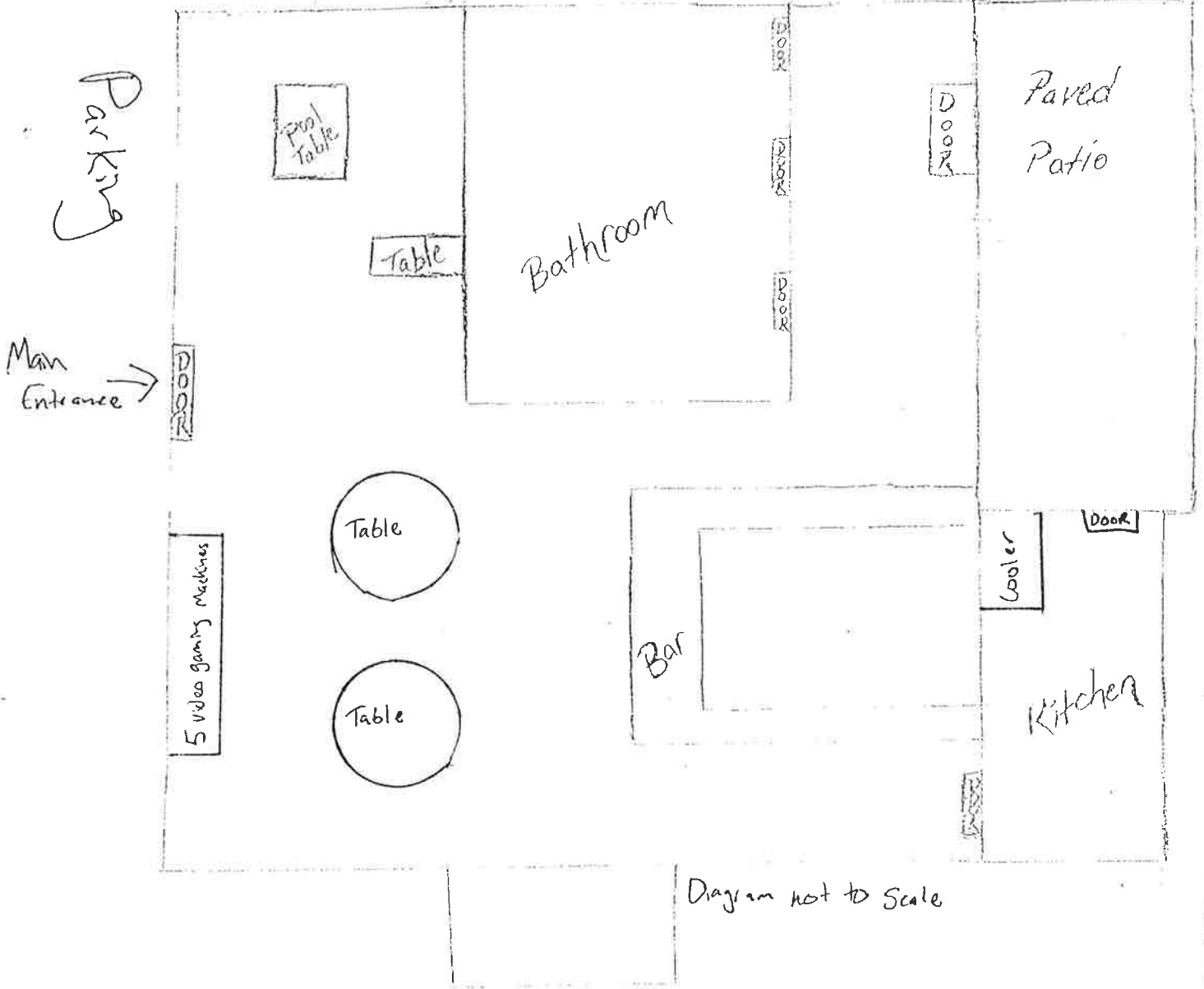
