Summary:

On 08/07/2023 at approximately 1607 hours, I, Deputy Souvannasing #381 was assigned to a cabaret license inspection of it Premier Wine and Spirits, 32400 Geneva Rd. I was informed that the business had applied for this license and that a review of the tavern was required. The owner Deanna L. Delimat gave me a tour of the premises and provided me with the theme and plans for the space. No violations of any county ordinance or state law were observe during the inspection, and based on my observations, a license should be issued to the tavern.

Narrative:

On 08/07/2023 at approximately 1607 hours, I, Deputy Souvannasing #381 was assigned to a cabaret license inspection of it Premier Wine and Spirits, 32400 Geneva Rd. I was informed that the business had applied for this license and that a review of the tavern was required.

The building is on the corner of CTH W and STH 50. The entrance to the establishment if on CTH W, on the west side of the road. There is a large parking lot that partially wraps around building in a "L" shape to the north and west of the building.

The bar entrance was on the north side of the building. The main entrance to the store is on the west side of the building. The main entrance had a handicap ramp and a set of stairs that led to the front door.

It should be noted this establishment is an alcohol store and a bar, split down the middle.

I met with Deanna L. Delimat who was identified verbally. Deanna is the co-owner of the establishment. Her husband Timothy A. Delimat was not present but is the other co-owner. Deanna first brought me to her office to show me the Class B Retailer's licenses. Deanna also should me her cigarette and tobacco products retail license and her food and beverage license. Each license was in Timothy's name. Photos of each licenses uploaded to Polaris. I gave Deanna a copy of the Kenosha County Ordinance 8.02.

The license was not properly framed and displayed when initially arrived. I advised Deanna that she needed to make the necessary changes and she did so.

The "Class B" licenses was issued through the town of Wheatland in Kenosha County. The Class B License was up to date with the start date of July 1 2023 – June 30 2024. The license was issued to Premier Wine & Spirits LLC with Timothy as the agent.

The bar section had chairs and couches on the exterior portion of the bar. The bar itself was near the north wall. Between the bar and the liquor store, there was a large enclosed gas fire place that help separate the two areas. There was a sign that stated no store bought purchases were permitted to in the bar area. The speakeasy (bar) hours are as followed:

Wed-Fri: 2pm-9pm

Sat: 1pm-9pm

Sun: 12pm-6pm

Deanna provided me with the key holder information.

Deanna provided me with a certificate of occupancy from the town of Wheatland, which was dated 06/14/2023.

I observed no minors in the bar at the time of my inspection. The establishment appeared to meet Kenosha County Ordinance 8.02 requirements. Based on my observation, I would recommend approval of the cabaret license for Premier Wine and Spirits.
