6:34 District Attorney Mike Gravely explained that the resolution was for a \$3000 media grant to be used for the purchase of iPads and a Microsoft Surface laptop. 
6:39 Capt. Hallisy advised that this resolution was the first step for the annual Country Thunder approval. This year Country Thunder has hired a local agent to represent them and provide communication with all agencies involved. They have hired former KSD Captain Ken Weyker. Hallisy stated everything is in order except the renewal of the Town of Randall liquor license. The Randall committee will meet soon, and the clerk as advised that they do plan to renew their license. The bond has been posted in the same amount as last year, \$225,000. Last year money was returned to Country Thunder, but exact amounts are not known until after the event. Signage expense may increase due to additional signs being used. Supv. Rodriguez inquired if any additional equipment

has been purchased for Country Thunder, Hallisy stated that equipment will be rented or borrowed again this year. A media day will be held in advance before the event for anyone wishing to tour the grounds.

Any Other Business Allowed by Law: 6:49 Supv Rodriguez questioned how the confirmed mumps case was being handled in the jail. Levin advised that currently inmates were being quarantined for a specific amount of time to restrict the virus from being passed to other inmates. Any inmates being released before the quarantine period has ended will be referred to the Health Department.
