6:33: Capt. Weyker presented the resolution. This is a re-application after the previous license expired. There were construction concerns. An inspection was performed by Keuny and Associates. The Building Inspector and Fire Department have now said that the first floor is habitable. In six months, when this probationary license would convert to a regular license, structural inspections will be done again to be sure permanent repairs are in place. Supr. Montemurro asked if repairs were actually made or were certain areas just cordoned off. She is concerned about any potential liability and if non-use of the second floor should be specified in the license. Weyker explained that the building was shored up to support the structure. What needs to be done is in the Town's hands; they must approve repairs. The responsibility is on the Building Inspector. Weyker gave his assurance that that he would stay in contact with the Building Inspector. Esposito added that the Building Inspector signs off and is responsible. Montemurro asked if there was a capacity change; having a cabaret license usually brings more people. Business owner, Richard Corduan, stated that only the first floor had been utilized anyway. Esposito asked if the business was closed for a while. Corduan replied five months. Esposito asked if this was due to the construction issues and Corduan replied yes.
