1. **EDWARD H. BIEHN, VICTORIA BIEHN**, 32712 45TH St., Burlington WI 53105 (Owner), requesting a variance (Section V. B. 12.28-7: which states that non-conforming structures which encroach upon the yard requirements of this ordinance, but which met yard requirements of the applicable zoning ordinance at the time of construction, may be structurally enlarged or expanded if the existing structure is located at least fifty (50) percent of the minimum setback requirement and further provided that the alteration does not create a greater degree of encroachment on yard, height, parking, loading, or access requirements in the A-2 General Agricultural Dist. to construct a 20' x 20' residential addition onto the north side of an existing non-conforming structure which is located **2.1** feet (required setback **40** feet) from the street property line on Tax Parcel #95-4-219-253-0311, located in the Town of Wheatland.
