**Supervisor Comments:** Supr. Singer commented that it is nice to be on this Committee.

**Chairman Comments:** Supr. Michel welcomed new members to the Committee. There will be a meeting on the 19<sup>th</sup> to discuss guidelines for Committees. Supr. Frederick asked what the process is for budget presentations. Michel explained that departments come to JLEC first. Singer asked if Joint Services comes to JLEC. Michel replied no, they go to their own Board. Departments reporting to JLEC are Sheriff, Clerk of Courts, District Attorney, Emergency Management, and Juvenile Intake.

**Resolution from the Kenosha County Sheriff's Department:**

1) 2010 WI DOT BOTS Intensive Sanctions Program Supplement Grant

Nancy Otis presented the resolution to accept \$5,084 from the WI Dept. of Transportation as a supplemental award for the 2009-2010 Intensive Sanctions Program managed by WI Community Services (WCS). They have an office on the second floor of the Safety Building. Grant funds will purchase a multi-function color printer; a Preliminary Breath Test (PBT) device; a PBT printer and cartridges; and be used to hire a limited term temporary data entry specialist. The \$1,200 match required is satisfied by redirecting \$800 of the Sheriff's adopted equipment budget, which was for a replacement fax machine for WCS, and \$400 through the County IT Department.

Singer asked how long the program has been in effect. Otis replied 11 years. Michel explained that this is the only mechanism to monitor second to fifth offense violators. WCS administers breathalyzer tests and UA's. This Chapter 85 program helps protect the community as well as monitor offenders. Singer asked what the total budget is for the program. Otis replied that funds of about \$50,000 are received as well as the in-kind match. Michel added that fees are also collected from the offenders. Otis reported that the yearly renewal application has been filed and that this will be brought to the Committee when received. Singer asked if there are any other providers that could provide this service. Otis responded no. Singer would like more information about WCS when the full grant is brought to the Committee.
