WHEREAS, Kemper Center is part of the 17.5-acre County Park that offers multiple public amenities including a historic mansion, art museum, soccer field, conference center, gymnasium, multi-use paths, rental facilities, and community gardens along the Lake Michigan shoreline, and

WHEREAS, Kenosha County created a comprehensive 10-year exterior building restoration and preservation plan for Kemper Center, and

WHEREAS, the building restoration plan includes repairs to prevent water infiltration and deterioration to windows, painted surfaces, masonry, and architectural details, and

WHEREAS, Kenosha County completed two phases of the restoration project with Phase three restoration underway in 2023, and

WHEREAS, a Community Development Block Grant (CDBG) is offering a grant of \$33,675 to support the 2023 restoration project, and

NOW, THEREFORE BE IT RESOLVED, that the Kenosha County Board of Supervisors authorizes the Division of Parks to accept and expend the CDBG from the City of Kenosha in the amount of \$33,675 and amend the budget as per the attached budget modification.
